



## RULES

Only 51,000 tickets will be sold

- \$100 each, 3-pack for \$250, 5-pack for \$375, Super Pack for \$500 (includes 6 – Home Lottery tickets, 15 – 50/50 Add-On® tickets and 5 – 100 Days of Winning® Cash Calendar™ Add-On tickets).
- All tickets in a 3-pack, 5-pack or Super Pack and all Add-Ons in a 5-pack or 15-pack must contain the same name and contact information.
- Tickets must be purchased and mailed within Saskatchewan.
- Only tickets that have been verified as paid for are eligible for the respective draws.
- Must be 18 years of age or older. Tickets cannot be purchased in the name of a minor.

## DRAW DATES

Bonus Ticket Sales Deadline: Midnight, February 15, 2019.

Bonus Draw Date: February 28, 2019.

Early Bird Ticket Sales Deadline: Midnight, March 15, 2019.

Early Bird Draw Date: March 26, 2019\*.

Early Bird Winner Announcement: March 28, 2019.

Final Ticket Sales Deadline: Midnight, March 29, 2019\*\*.

Final Draw Date: April 9, 2019.

Grand Prize Winner Announcement: April 11, 2019.

Only tickets purchased before midnight, February 15, 2019, will be eligible to win the Bonus Prize. Bonus draw will commence at 10 a.m. February 28, 2019.

\*Only tickets purchased before the Early Bird ticket sales deadline of midnight, March 15, 2019, are eligible to win the Early Bird Prize. If all tickets are sold by the Early Bird ticket sales deadline, all draws will commence at 8:30 a.m. March 26, 2019. The top prize winners will be announced on March 28, 2019.

\*\*If tickets remain after the Early Bird ticket sales deadline, then only the Early Bird draw will commence at 8:30 a.m. March 26, 2019. Final ticket sales deadline is midnight, March 29, 2019. The remaining prize draws will commence at 8:30 a.m. April 9, 2019. The top prize winners will be announced on April 11, 2019.

## **DRAW ORDER AND PROCEDURE**

The first draw is for the Bonus Prize. The next draw is for the Early Bird Prize; then draws are made in the order of the ascending retail value, beginning with the prizes of least retail value.

After each draw, including the Bonus and Early Bird draws, the winning ticket number is recorded and the ticket number is eligible for subsequent draws. Each ticket purchased before the Bonus ticket sales deadline is eligible for 1,005 prizes. Each ticket purchased after the Bonus ticket sales deadline but before the Early Bird ticket sales deadline is eligible for 1,004 draws. Tickets purchased after the Early Bird ticket sales deadline will be eligible for the remaining 1,003 draws. All draws will be held at the offices of Deloitte LLP. The top valued prize draw announcements may be televised at the Grand Prize Showhome.

Prize draws follow a strict set of procedures, with draw control oversight by Deloitte LLP and under licensing approval by the licensing body, Saskatchewan Liquor and Gaming Authority (SLGA).

A maximum of 250,000 50/50 Add-Ons are available for sale. There are 100 prizes in the 100 Days of Winning Cash Calendar Add-On with a total prize value of \$100,000. There will be one big winner everyday beginning April 15, 2019. A maximum of 48,000 100 Days of Winning Cash Calendar Add-Ons are available for sale. 100 Days of Winning Cash Calendar Add-On winner's information will be posted daily on the lottery website beginning April 15, 2019, according to the sequential manner in which they were drawn.

In the event that all tickets are sold by the Early Bird ticket sales deadline of midnight, March 15, 2019, the Add-On draws will take place on March 26, 2019. If tickets remain after the Early Bird ticket sales deadline, the Add-On draws will take place April 9, 2019.

All winners of prizes will be notified in writing by Deloitte LLP as to what they have won and how to claim prizes. All prizes must be accepted as awarded with no cash equivalents available unless otherwise described in the brochure.
